## **REGULAR MEETING**

### **DECEMBER 11, 2019**

The regular meeting of the Mount Penn Borough Municipal Authority was held on Wednesday, December 11, 2019, in the meeting room of the John A. Becker Municipal Building, 200 North 25<sup>th</sup> Street, Reading, PA 19606 at 7:15 p.m.

The meeting was called to order by Chairman Thomas Smith. The following Board members were present:

Motioned by Tom Smith, seconded by Joe Boyle to approve the minutes of the November 13, 2019, as presented. The motion carried unanimously.

### TREASURER - Alfred Worrall

The bills for the month of November 2019 were reviewed.

Motioned by Al Worrall, seconded by Tom Smith to approve the November 2019 Treasurer's Report. The motion carried unanimously.

Scada Lease from Fulton bank has 1 <sup>1</sup>/<sub>2</sub> years left on loan.

Mt . Penn Borough rent payments for rent include payment for employee insurance . Both are included in payment but are itemized in general ledger.

Payment to Central Berks is for Mt. Penn Waters share of the cost of the id machine.

Proposed budget will be a 3% increase. Board will review the proposed budget.

The largest budget items for 2020 will be meters and the new dump truck.

**ENGINEER**- Bradley Smith

Exeter Township is replacing the culvert on Butter Lane in the spring. They are asking if the water authority would like to share the cost of the engineering cost which will include work needed for the authority. All were in favor of this.

The Spook lane study was completed. There were some boundary issues due to missing pins and monuments.

Discussion was also made about a similar problem at Carsonia Lake with a portion of the property where a nearby resident was using our property for their own needs. Mark says that he has a copy of the survey done by Berks Survey that should help show the boundaries. The total cost of the Perkiomen Ave project was \$1,717,092.00. Mt Penn Water Authority portion is \$990,762.00. The actual numbers will be issued by Penndot sometime soon. The Small Grant requested for the generators is \$359,949.00 and matching is \$63,520.00.

## **BUSINESS OFFICE**

There were 40 shutoffs on December 10. Most have been turned on after payment. Quickbooks software was purchased for the office to allow 2 users to use at the same time. 3.0 % Rate increase notice will be printed on January bills which will be effective April 1, 2020 bills.

The new meter surcharge of \$5.00 will be added on the January bill.

Credit card charges are currently being analyzed with help from Xpress Bill Pay to lower our costs.

Lynxcare Lite security package was sent from Pete Muhlenberg at Lynx. The information will be read by the board for possible future consideration.

# SOURCE WATER PROTECTION

Joy Boyle had a meeting with Liberty Environmental, Berks Nature and Larry Lloyd to review the growing greener grant. The discussion about the dredging of Crystal Lake renaming the work as sentiment relocation for grant requirements and can be used later to fill in back sections of the lake to save money. Joe and Kelly drove to Bucks County to talk to another company trying to get grants for their lake project.

DEP supports Mt. Penn BMA lake project and Larry Lloyd is helping to try and secure grants. One key of the project is to make sure the lowering of the lake is done only one time. Fish will need to be relocated. Also possibly a valve to control the lake water level may need to be installed. Cleaning out the bottom to free up the underwater springs. Multiple grants may be needed and could take 3 years. Letters are needed from representatives to help achieve the grant. RCAV meeting was attended by Ann Sellers but was very short. Access to outside bathrooms at the Rec are still being discussed. The board expressed concerns due to possible vandalism and other situations made possible without secured measures. The authority should have final say on the matter. Parts of the lake need to be cleaned up with possible help by the Boy Scouts.
