#### **MINUTES**

#### **REGULAR MEETING**

### **NOVEMBER 13, 2019**

The regular meeting of the Mount Penn Borough Municipal Authority was held on Wednesday, November 13, 2019, in the meeting room of the John A. Becker Municipal Building, 200 North 25<sup>th</sup> Street, Reading, PA 19606 at 7:03 p.m.

The meeting was called to order by Chairman Thomas Smith. The following Board members were present:

Mr. James Frank, 518 Fountain Ave asked what organization maintained Carsonia Park. Mr. Frank will attend a future RCAV meeting. Joe Boyle explained the water authority is working on making the necessary storm water corrections on the lake through a series of grants.

Motioned by Tom Smith, seconded by Joe Boyle to approve the minutes of the October 9, 2019, as presented. The motion carried unanimously.

## **TREASURER**- Alfred Worrall

The bills for the month of October 2019 were reviewed.

A discussion was held regarding the monthly documentation being provided to the board and the required time line for providing this documentation.

Motioned by Al Worrall, seconded by Tom Smith to approve the September 2019 Treasurer's Report. The motion carried unanimously.

## **ENGINEER**- Bradley Smith

Arro is waiting for the 2018 Audit needed to finalize the PennVest loan requirements. Al Worrall will be looking into other funding options for the Perkiomen Ave project. Discussion continued regarding the total cost of the project. The final bill has not been received but will now include the Betterment Section from 27<sup>th</sup> to Neversink Rd that did not qualify for reimbursement from PennDOT. A final walk-through should be scheduled.

The rate study preliminary findings are complete. Arro would like to schedule a workshop to review the finding with the board. After discussion, the workshop was schedule to take place at 6:00 PM on Wednesday, December 11, 2019. The next regular scheduled board meeting will be advertised to begin at 6:00 PM.

The surveyor on the tank has been completed and a map will be generated.

The application for the Small Water and Sewer grant in the amount of \$359,949.00 is ready for submittal. The grant will fund the install 3 emergency generators. There is a 15% match. A letter asking for Senator Schwank's and for Representative Rozzi's support will be mailed. Joe Boyle will following up.

**Resolution 09-19** requesting a \$359,949.00 Small Water and Sewer grant from the Commonwealth Financing Authority to be used for the installation of emergency generators. Motioned by Tom Smith, seconded by Ms. Dudash. Motion carried unanimously.

# **WATER SYSTEM** -Matt Hauck

Matt Hauck reported he attend a meeting in Lower Alsace Township with Township Supervisors, DEP regarding the amount of water running off the mountain. DEP was called to investigate complaint from a resident on Park Lane.

The monthly maintenance report was reviewed.

Two item to be considered for purchase by the end of 2019: Quick release boom for the backhoe estimate cost of \$20,000.00-tabled until the December 11<sup>th</sup> meeting. Line locator estimate cost \$5,000.00-this item is already in the budget for 2019.

Matt Hauck asked the board to consider a holiday shut-down on Thursday, December 26<sup>th</sup> and Friday, December 27<sup>th</sup>. The employees would use paid time off. The discussion was tabled until the next meeting.
